Mr. LaRussa has an extensive background owning and operating businesses ranging from financial services, real estate, industrial distribution and various consumer packaged goods companies. He is on the Board of Directors for Jack's Family Restaurants, Security Engineers and First Commercial Bank, a Synovus bank in Birmingham, AL.

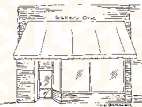
